CALL TO ORDER: Board Chair Evelyn S. Wilson welcomed everyone in attendance. The meeting was called to order. The Board led in the Pledge of Allegiance to the flag.

RECOGNITION: Community & Communications Coordinator Susan Hoke recognized Colonel Mike Whitehurst, JROTC at SouthWest Edgecombe High School, as the employee of the month.

Assistant Superintendent Dr. Marc Whichard recognized coaches and members of the Tarboro High School Varsity Football Team and congratulated them for winning the 1AA State Football Championship. This is the fifth state championship the football team at Tarboro High School has won.

West Edgecombe Middle School Principal Claude Archer stated their focus is on educating and developing the whole child.
